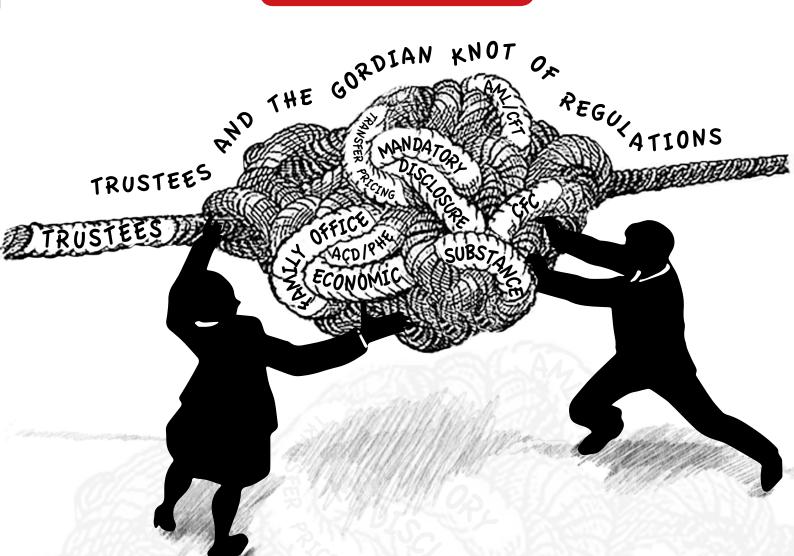




STA CONFERENCE 2019

Prior to that, he served as Chief Executive Officer at the Institute of Banking and Finance and Head of Strategic Development Division in the Development Group in MAS. Before these stints, Mr Paul Yuen was seconded to the Public Service Division in the Prime Minister's Office as Head (Strategy Unit) in the Strategic Policy Office. Before his secondment to the Public Service Division, Mr Paul Yuen was Assistant General Counsel at MAS.

Mr Yuen graduated from the National University of Singapore and is an advocate and solicitor of the Supreme Court of Singapore.

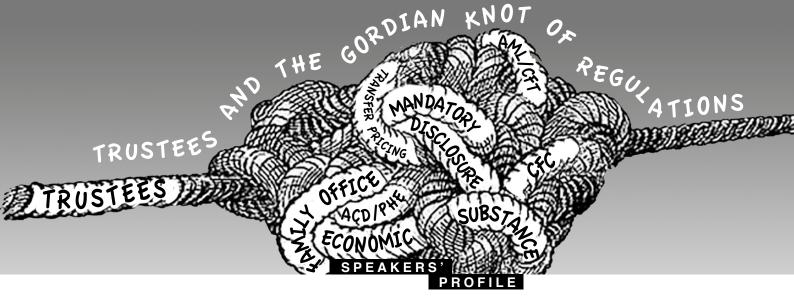

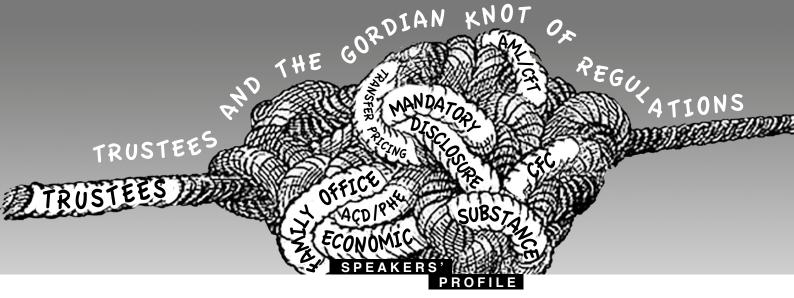
